#### **HOUSE RULES**

- Time keeping is imperative. We have a business to run and expect you to be ready and on the floor for the opening times.
- We have a dress code for a reason; please make sure you adhere to it! It is in your best interests to look your best.
- Anyone found drunk and unable to work will be asked to stop work and will be escorted to a means of safe transportation to their address provided in their file.
- Anyone thought to be under the influence of, in possession of, or trying to purchase or sell drugs within the premises will be escorted from the building directly into the hands of the police.
- Manners cost nothing, please use them at all times, and remember you are representing Eden 1 and also yourselves. We want you to earn money rudeness will not get you a dance.
- Customer service is compulsory, we do not want our customers to feel pressured
  or intimidated in any way. Please allow customers to get a drink and settle in
  before approaching them and introducing yourself.
- We are now legally limited to the number of girls permitted to work in the venue at any one time, so spaces are precious for this reason if you make a booking and don't keep it you may be charged the fee for that shift.
- Pole shows are necessary, financial penalties will be incurred if you refuse.
- One girl, one customer! Please remember your dancer etiquette!
- VIPs and dances must not be over or under charged
- We work hard to provide a happy working environment for our performers, bitching and school yard bullying will not be tolerated, if you feel you are a victim of this please see your dance manager (Hennessey). All complaints will be dealt with in the strictest confidence where possible.
- Financial penalties are in operation, please see detailed list on notice board.
- Dance room rules: One foot on floor at all times, no hands on knickers, 12 inch rule in operation, no sitting on laps and strictly no contact between dancers and customers. If you are unclear on the rules of our dance room please see the dance manager and a demonstration of an acceptable dance will be given by one of the dancers.

## **Performer Agreement**

This agreement sets out the terms of the performer renting there own space in private dance room and charging clients rates of £10 & £20 retrospectively, also a VIP rate of £45 per 15 minutes with £5 commission to be paid to the club.

### Venue undertakings

Eden 1 will provide the premises and ensure that there is adequate security available at all times that the venue is open and that the premises meet the requirements of any public entertainment license and SEV license.

Eden 1 will provide all performers receipts for commissions, house fees and financial penalties.

Lockers will be provided and maintained to a useable standard in the changing rooms for all performers.

Any complaints made to management by performers will be dealt with appropriately and professionally.

Performer's given names or personal information will not be revealed by the venue to any third parties other than the local authorities.

#### Performer undertakings

To pay the venue the house fee daily at the end of the shift. Not to use the premises other than for the agreed permitted use. Not to provide the address for use of service in any legal proceeding whatsoever. To obey the house rules and regulations and the SEV guidelines, a copy of which are provided on request and currently displayed in the changing rooms.

## **CODE OF CONDUCT**

Dancers are expected to be at the club half an hour before your shift starts. You should arrive dressed tidy appropriate clothing and look presentable to the mainstream public from outside the club at all times. Arrive and leave the premises quietly and with respect.

We are legally limited to the number of performers on any one shift, therefore any shifts that you book yourself in for is a space which could have been rented to another performer, so you take on responsibility for the payment of that space in the event of absence.

You must be changed and ready to work at the start of your shift.

Hair, make-up, clothes and jewellery should be high and continuous. Tutus and tiaras should remain at children's parties and hen parties... you are not at either, you are working in a classy establishment therefore suitable attire must be worn at all times. Although this is stating the obvious see-through underwear is NOT permitted as this is a TOPLESS ONLY venue. Long dresses and professional exotic dancewear is preferred over bikinis and underwear sets, but this is not a required but would be appreciated.

Shoes must be worn at ALL times within the club.

Chewing gum is no longer allowed... mints are available behind the bar and mouthwash is provided free of charge in the changing rooms.

Wearing customers clothing is not allowed. This includes jackets and coats.

Under no circumstances should you fraternise outside of work with other members of staff and customers. This will result in instant termination of your agreement, and will no longer work at Eden 1.

Partners and family members are not allowed on the premises while you are working and should refrain from trying to gain entry.

Working at Eden 1 means that you will have to participate in pole shows and promoting of the club, this is for your benefit as well as ours... a busy club with happy patrons will increase your earnings!

Foul language, shouting and arguing with customers or other employees or performer is not permitted in the club under any circumstances.

Lewd behaviour, prostitution and solicitation will NOT be tolerated and will result in INSTANT DISSMISAL.

You may drink with customers, but you may not leave your drink unattended at any time, or get inebriated to the point of not being professional.

Under no circumstances should you give out your personal details/telephone number to customers. Similarly you must not take any telephone number or other contact details from customers or arrange meetings off the premises, although you can provide information to customers of Eden 1 opening times.

As you are aware smoking is not permitted in the club, if you are a smoker you must get fully dressed and go out of the front entrance of Eden 1 after notifying your dance manager (Hennessy) due to fire regulations, please note only three performers are permitted to be out smoking at any one time.

Food and rest breaks are flexible, although please use your common sense and if the changing rooms are busy with girls starting or finishing a shift then please come back at a quieter time, also if you are going to be off the floor for a period longer than 15 minutes please inform the dance manager.

VIP and Stage show commission should be paid immediately after, if not before, any show or dance takes place.


For a single, 1 song 'lap dance' the price is £10. For double girl dances the price is £20 per girl. Do not under/over charge. This results in instant dismissal.

Knickers should not be touched at any time during your dance; we promote tease not sleaze, so ensure your dances are clean. Please maintain the 12 inch rule at all times during your dance.

Make sure you receive payment up front for dances as the venue will not be responsible for chasing up payments from your customers.

Stage shows must be undertaken with professionalism and decorum! They must be at least 2 songs long; under no circumstances must a performer whip or burn the customers.

The VIP room should be used professionally and with etiquette. The performers must follow exactly the same rules as in the normal dance room, the customer is paying for your time and under no circumstances is this to be sold with the impression of any closer, naughtier dancing or use of anything outside of The Doll House clubs rules. Please consider your fellow performers whilst in the VIP room and maintain a professional atmosphere at all times.











10 years ago I was severely disabled by a stroke. Then 5 years ago I was dumped by my wife after 32 years shortly followed by our two children. I became severely depressed through lonliness. After a while I decided to try to re-integrate with life beyond my front door, but being a non-drinker, I found that pubs and bars had established drinking groups so that failed. I tried pub quiz nights but that regular teams dominated. One night my morale was at rock bottom. I was shuffling along the prom in the rain contemplating my miserable future prospects and thinking of the stash of pain killers I had accumulated at home when a voice called to me from a club doorway asking if I was OK We chatted and he suggested I went inside for shelter. I said I didn't drink and that I had never been in such an establishment. I was assured I would be made welcome and that's how I first met s lap dancing club Eden 2. I sat down and was joined by a young lady. We exchanged names and chatted for half an hour when I decided to go home, feeling much better and ignoring the pills. The following week I went again, met the same young lady who greeted me by name which gave me a boost, proving I was not a useless piece of flotsam but had an identity.
